## Chubb Group Personal Accidental Insurance Claims Guidelines 团体综合人身意外伤害保险理赔操作程序

Because each claim is unique, the following claims guidelines are general only and reference should always be made to the actual policy under which a claim is to be made. Please contact your broker or a Chubb Claims Representative as soon as possible as claims guidelines can differ depending on the specific facts of a claim and there can be no rigid structure applied to each type of claim.

## A. Notification 索赔通知

In the event of any occurrence which may give rise to a claim under the policy, a Claim Form, to be completed and signed by the insured & employer's company chop affixed (for group policy) should be immediately sent to the claims representative by email at *chn.claims@chubb.com*

## B. Supporting Claim Documents Required 需要提交的理赔资料

The following certificates and documents shall be provided to Chubb Insurance (China) Co., Ltd. by the claimant for payment of **Benefits for death**:

对于身故保险金的申请,索赔申请人应向 Chubb 提供以下证明和资料:

- 1) the original of a claim form filled in and signed by the claimant;
- 2) legal documents establishing the identity of insured, and any and all beneficiaries and their resident registration;
- 3) an official death certificate of the Insured issued by the proper authority, evidence that the resident certificate of the Insured has been cancelled;
- 4) reports issued by police and the complete medical records in relation to the occurrence of event which result in the death;
- 5) notarized documents to prove legal rights of inheritance when the insurance is the insured heritage;
- 6) other information may be required which is necessary for the Chubb Insurance (China) Co., Ltd. to process the claim.

- 2) 被保险人及身故保险金受益人的有效身份证明和户籍证明;
- 3) 国家卫生行政部门认定的医疗机构、公安部门或其他相关机构出具的死亡证明及户籍注销证明;

- 5) 保险金作为被保险人遗产时,须提供可证明合法继承权的相关权利文件;
- 6) Chubb 在处理索赔时可能要求的其他信息。

The following certificates and documents shall be provided to Chubb Insurance (China) Co., Ltd. by the claimant for payment of **Benefits for disablement**:

对于残疾保险金的申请,索赔申请人应向 Chubb 提供以下证明和资料:

- 1) the original of a claim form filled in and signed by the claimant;
- 2) legal documents establishing the identity of the Insured;
- 3) reports issued by police and the complete medical records in relation to the occurrence of event which results in the disablement;
- 4) reports issued by hospital or local evaluation authority which confirms the level of disablement in line with the policy definition. Chubb Insurance (China) Co., Ltd hereby reserves it rights to request the submission of further certificates issued by governmental disability evaluation organization.
- 5) other information may be required which is necessary for Chubb Insurance (China) Co., Ltd. to process the

- 2) 被保险人的有效身份证明;
- 3) 与该意外事故有关的警方报告和完整的病历卡;
- 4) 由医院或司法鉴定机构所出具的与保险合同约定的残疾释义相符合的被保险人伤残程度的鉴定书。Chubb 有权要求被保险人作身体检查或提供有关的检验报告,并保留要求提供其它与残疾有关的证明或资料的权利;
- 5) Chubb 在处理索赔时可能要求的其他信息。

The following certificates and documents shall be provided to Chubb Insurance (China) Co., Ltd. by the claimant for payment of Benefits for medical treatment or hospital income:

对于医疗保险金或住院津贴的申请,索赔申请人应向 Chubb 提供以下证明和资料:

- 1) the original of a claim form filled in and signed by the claimant;
- 2) legal documents establishing the identity of the Insured;
- full and complete of medical records, medical certificates of diagnose, pathological diagnose reports, hospital discharge reports/summaries, and original of invoices of charges and expenses incurred for the medical treatment;
- 4) Chubb Insurance (China) Co., Ltd. may request for further information in relation to the treatment when processing the claim.

- 2) 被保险人的有效身份证明;
- 3) 符合保单定义的医院出具的完整的病历卡、疾病诊断证明书、病理报告、出院小结及医疗费用收据的原件;

The following certificates and documents shall be provided to Chubb Insurance (China) Co., Ltd. by the claimant for payment of other benefits not mentioned above:

- 2) certificates and documents required by specific Benefit, if applicable;
- 3) legal documents establishing the identity of the Insured;
- 4) Chubb Insurance (China) Co., Ltd. may request for further information in relation to the treatment when processing the claim.
